#### **Notes**

- All fixtures <u>must</u> be played as per official schedule, unless there are exceptional circumstances as laid out in this manual; some clubs do not have any dates to re-arrange a fixture to.
- Some fixtures will seem irregular to some teams. This is in order to accommodate venue, multiple teams, National League fixtures and non-availability requirements of some clubs.
- All League matches will consist of the best of 5 sets. In the case of league matches 3 points are awarded for a win, 1 point for losing a match, and no points for forfeiting a match.

### League structure

**All divisions**: all the teams in each division will play each other home and away once between 28/09/2018 and 30/04/2019.

All teams in a division will play each other once at home and once away.

## **SVA** competition rules

#### Club/Team administration

**1.** EVA rules will apply to the conduct of SVA matches where not varied by local rules.

The Sussex Volleyball Association has a zero tolerance policy against poor behaviour on court and specifically any bad behaviour directed at the match officials or across the net to the opposing team. This applies to players, substitutes, coaches and anyone associated with your club. Penalty points will be applied for any "Penalty, Expulsion or Disqualifications" given by the referee in accordance with Rule 30 of the SVA handbook.

**2.** All clubs will maintain a financial goodwill deposit of £35.00 with the SVA. This is intended as an additional token of commitment and will enable the SVA Committee (SVAC) to levy appropriate fines against teams which infringe any of these rules.

In the event that all or any of the deposit is forfeited, the deposit must be made up in full within 14 days of despatch of the fine notice.

Fines not paid...

Within 14 days loss of all points during the unpaid period Within 4 weeks expulsion of team from League and KO Cup

- **3.1.** All league entry fees and goodwill deposits must be paid by the 5<sup>th</sup> August 2016 and until such money is paid in full any matches played by the teams concerned shall be deemed to have been lost 3 0 by the offending team.
- **3.2.** Each team must register with the SVA the names of all players in that team by completing the player registration form. Enrolment fee is £10.00 per player. Player registrations must be completed before the start of the team's first game. Further registrations may be made on the day of a match as long as an email is sent to the division secretary and SVA treasurer with the player's details and evidence payment has been made by bank transfer. Players who are registered EVA coaches and can show their current EVA coaching card are exempt from the enrolment fee.
- **3.3.** After the end of January, there will be no transfers between teams or clubs unless an exemption is made by SVAC.

#### **Fixture arrangements**

- **4.** All matches are automatically confirmed on publication of the definitive fixture programme on the SVA website.
- **5.** All disputes shall first be considered by the League Managers and when necessary referred to the SVAC.
- **6.** No matches shall be played after the final scheduled fixture shown in the handbook unless agreed under rule 8.1.

7.

**8.** All League matches will consist of the best of 5 sets. In the case of league matches 3 points are awarded for a win, 1 point for losing a match, and no

points for forfeiting a match.

League positions are decided on points won. In the event of teams being equal on points the final league positions will be decided on sets difference, then sets for, then sets against and if this doesn't give a clear placing with respect to promotion/demotion to have a playoff at a neutral venue.

- **8.1.** The fixture list is published in draft form for consultation in July/August. Fixtures may only be re-arranged at short notice during the season in the following circumstances, or with the agreement of the league manager:
  - a. The venue is unavailable due to unforeseen circumstances. The home team must inform the designated club contact of the visiting team at least 3 days before the fixture date.
  - b. Difficult weather conditions on the day of the match
  - ...and in both cases the League Manager and Fixtures Secretary **MUST** be informed.

Fixtures may be re-arranged for other reasons with the agreement of both teams. All re-arrangements are subject to the following rules:

A date for the postponed match must be agreed within 28 days of the date the game was postponed. The team postponing the game is primarily responsible for rearranging the game and will be liable for the penalty points under rule 28 if adequate arrangements are not made. If a suitable date cannot be found the team who did not initiate the postponement can claim the game. All games must be played by the end of the season prior to the AGM.

- **9.1.** Failure of teams to attend matches (except as under Rules 8.1 and 8.2) will be dealt with as shown in the penalty point table rule 30.
- **9.2.** Expenses MUST be claimed through the SVAC and not directly from the offending team. The final decision on the level of any expenses to be claimed will rest with the SVAC.
- **9.3.** Where the team offended against is the home team a completed score sheet must be submitted to the League Manager. Where the team offended against is the away team a team list must be submitted to the League Manager.

#### League match arrangements

- **10.1.** It is the Home teams responsibility to **email** the away team to confirm the fixture a minimum of two weeks prior to the match. For those matches where a Home team is playing at the away venue it is the responsibility of the home team to confirm that all details venue, start time, officiating is all in place. It is the Away teams responsibility to ensure that this has been organised and confirmed.
- **10.2.** The time published in the Handbook is the warm-up start time and except where varied by the home team entry in the handbook, the first ball is due to be served 30 minutes later.
- **10.3.** The first ball will not be served until both teams and officials are on court. Any team causing a delayed start will be penalised as follows:

- **10.4.** It is the responsibility of the home team to start on time and provide enough court time to play the game. If the game then overruns the home team forfeits the match
  - 11. The minimum number of players for the Men's lowest Division and the Ladies Division is five, in which case three shall be front court players. Serving penalties shall apply for teams playing with five. If a team is playing a libero and only have 7 players then if a player is injured the libero can substitute as a normal player for the injured player immediately. If a team playing with six suffers an injury and can only continue the match with 5 players serving penalty will be applied.
  - **12.** Clubs may field mixed teams in the Men's Divisions but the net must remain at Men's height.
  - **13.** The minimum roof height shall be 7 metres for Men's Div. 1 and Ladies League matches. Teams can elect to play at home (by informing the Fixtures Secretary before the beginning of the season) if their opponent's hall does not meet this requirement.
  - **14.** All teams must turn out in matching shirts with numbers attached. Only if the mismatching shirt is shown on the score sheet will the penalty points apply as in rule 30.
  - **15.** The home team must arrange for the following officials at matches:-
    - EVA Qualified Referee
    - Competent 2nd Official
    - preferably 2 lines persons but none will be acceptable
    - Scorer

When the SVA have assigned a referee two competent line judges must be supplied by the home team

The home team must provide a qualified 1st referee for ALL matches (Men's and Ladies) or the game will be forfeited by the home side. If there is any doubt over the referee's qualifications, the game must be played on the night with any comments being put on the score sheet. A final decision on the match result will then be made by the SVAC.

The details of these officials must be entered on the score sheet and **must** include the referees qualification and number. Penalty points for noncompliance will be applied as per table in point 30.

15.1 If SVA arrange a referee they will be paid £20 per game.

The home team in any fixture must make available at least four good quality balls for the use of the visiting team if they require them.

- **16.** The home team secretary must input all results or text results to League Republic within 24 hours and text or email the appropriate Division manager within 24 hours two photos of the score sheet.
  - Whole score sheet

- 2. Close up of the remarks, summary and players
  - a. Score sheets must be completed legibly with team names, set scores and the names of all players and officials. All matches must be recorded on EVA score sheets.
  - b. Score sheets are to be completed in triplicate and copies as follows:-

- c. Only the 1st referee may complete the remarks box on the score sheet provided the correct FIVB protocol has been observed.
- d. Home teams must have available team sheets for both home and away teams for the scorer. These can be viewed on electronic devices or printed from the SVA website. Coaches/captains must advise the Scorer of players playing up or down.
- **17.** Teams consistently guilty of inadequate match organisation will be subject to penalties as laid out in Rule 30 and to review by the SVAC.
- **18.** Promotion and relegation will in general operate on a "two up, two down" basis but may be subject to variation by the SVAC in order to administer variable entries at the start of the season.

### **Eligibility of players**

- **19.** No player may play for more than one club in the league. This rule also applies to Challenge Cup matches. Exceptions will only be made with the agreement of SVAC. Ladies may play in the men's division for another club if they do not play for the men's team within their ladies team club. These ladies should be highlighted to the SVAC before the start of the season.
- **20. Movement of Players within a Club**. Where a club has more than one team within the leagues, they must register players for a single team within that club. However, one player per match may play up any number of times for a team within that club for which they are not registered as a player. However a player may only play down if the team would otherwise only have 5 players.
- **21.** When a club expands to have an additional men's or ladies team for the first season they can play two players up at any point. They can also play two players down to make up a team of 6 players.

In the case of players under 18 as at 1st September, they are eligible to play for any team within the club therefore overriding any rule restricting only 1 player to be played up/down in a match. This rule does not apply to Cup matches.

If any club suspects an infringement of this rule the League Manager shall check the score sheets to assess the validity of the allegation.

**22.** Players transferring between clubs during the season will have to wait one game from the date the relevant league secretary is notified in writing of the transfer request.

**22.1.** Players transferring between teams within the same club will be eligible to play for the new team from the date the relevant league secretary is notified in writing. If the same player wishes to transfer a second time they will have to miss one game from when the league secretary is notified in writing.

### Sussex Player of the Season award

23. There will be one award for each division. After each match the team captains shall nominate a player of the match from the opposing team and the referee will confirm that he agrees with the selection. If necessary the referee may change the vote if he considers that either captain's vote is unsportsmanlike. The player with the most recommendations at the end of the season will be the winner.

The player of the match nomination shall be made at the end of the match, before the players leave the hall.

Players playing up or down should be noted on the score sheet and are ineligible to receive the player of the match award.

### **EVA** requirements

- 24. U18 players in a team must be clearly identified on the player registration forms. The SVA remind all clubs with U18 players to ensure that they are aware of and follow the guidelines contained in the EVA Child Protection Policy. All clubs affiliated with the SVA should have received a copy of this policy from the EVA. If this is not the case please contact the EVA National Office on 01509 227722. Further any club with U18 players should also ensure that at least one member of their club possesses the appropriate CRB check and that person is in attendance where U18 players are either playing or training if a parent is not in attendance.
- 25. All clubs must be affiliated to the EVA. (See Constitution Para. 10) This has personal indemnity implications and is an imperative. Affiliation applications and payment of fees must be made directly between the club and the EVA in August each year. No matches may be played by a club unless the SVAC has received confirmation that the club is affiliated. If during a season it is discovered that a club has not affiliated to the EVA all teams within the club will have all points won to that date deducted.
- **26.** Each club should have a qualified coach who is registered with the EVA and whose registration is up to date with the EVA.

#### **SVA** administration

- 27. It is compulsory for each club to be represented at every SVAC meeting (see Constitution Para. 4). Failure to attend SVAC meetings is a breach of SVA rules and will result in penalties as listed in the table under Rule 30.
- **28.** The SVAC reserves the right to vary the number of divisions depending upon the number of entries that are received for the league.
- **29.** Registered EVA coaches have free membership to the SVA if they submit a details of their registration number with the player registration form.

**30.** Teams will receive penalty points for poor or inadequate organisation. For every 10 points accumulated by a team they will be deducted 1 league point. Any team accumulating 100 points will be immediately suspended for the remainder of the season from all SVA competitions.

<sup>\*</sup> Any cards given by a referee must come with a report from the referee and both team captains and will be brought to the committee for discussion. This will be in accordance with the EVA sanctions stated as follows:

Warning - No Sanction Yellow Card Penalty - Sanction Red Card Expulsion - Sanction Red and Yellow Card jointly Disqualification - Sanction Red and Yellow card separately

**31.** Should there be any circumstances not covered by the preceding rules, the final decision will rest with the SVAC.
